In case of abuse, there's risk of rupture, fire, heat, leakage of internal components, with could cause casualty loss. Abuses include but not limited to the following cases: charged for long time, short circuited, put into fire, whacked with hard object, punctured with acute object, crushed, and broken.

The lithium ion batteries are not hazardous with eye and skin contact under normal circumstance. In case of internal hazardous substance leaking an hazardous substance, following measures should be taken if body parts contact with these substance:

皮肤接触: 皮肤接触后马上用肥皂和大量清水冲洗皮肤

After Skin Contact: In case of contact, immediately wash skin with soap and copious amounts of water.

眼睛接触: 提起眼皮用清水冲洗 15 分钟, 立即就医。

After Eye Contact: In case of contact, flush eyes with clean water for 15 minutes while lifting eyelids. Get prompt medical attention.

吸 入:如有吸入,迅速脱离现场至空气新鲜处。如果停止呼吸,进行人工呼吸。如果呼吸困难,供给氧气。

After Inhalation: If inhaled, remove to fresh air. If not breathing give artificial respiration. If breathing is difficult, give oxygen.

食 入: 如有知觉用水冲洗口腔。就医。

After Ingestion: If swallowed, wash out mouth with water provided person is conscious. Call a physician.

Fire-extinguishing Methods and Extinguishing Media: Copious amounts of cold water are an effective extinguishing medium for lithium batteries. Don't use warm or hot water. Don't use Halon type extinguishing material.

Attention in Fire-extinguishing: The Firemen should put on antigas masks and full fire-fighting suits.

当电池发生泄漏,液体可以用砂,土,或其他惰性物质吸收,受污染的区域应同时通风。 When leakage of batteries happens, liquid could be absorbed with sands, earth, or other inert substance, and the contaminated area should be ventilated meantime.

未放热或燃烧的破损电池, 应装入密封的塑料袋或容器。

Damaged batteries that are not hot or burning should be placed in a sealed plastic bag or container.

Storage: Store and used far away from heat, sparks, open flame, or other heat ignition sources, and under room temperature(<30°C) in ventilating and dehumidifying environments




